PURPOSE / AIM OF REPORT

To present to council the comments and representations received on the 2013/2014 Draft Budget which was tabled on 28 March 2013. The comments and representations emanate from the intensive ward committee and public engagements during October and November 2012 and again ward committees meetings during April 2013. The IDP, budget Tariffs and Budget related documents were published for comments. The closing date for comments was 26 April 2013.

INLEIDING

Om die kommentaar en vertoë oor die 2103/1014 Konsepbegroting wat op 28 Maart 2013 te tafel gelê is, aan die Raad voor te lê. Die kommentaar en vertoë spruit uit die intensiewe wykskomitee- en openbare raadpleging tydens Oktober en November 2012 en wykskomiteevergaderings wat in April 2013 gehou is. Die GOP, begrotingstariewe en begrotingsverwante dokumente is vir kommentaar gepubliseer. Die sluitingsdatum vir kommentaar was 26 April 2013

SUBMISSION OF DRAFT BUDGET

The Draft Budget and Budget-related documents were forwarded to National and Provincial Treasury and other sector departments. Notices were placed in local newspapers and the Draft Budget was placed on the municipal website inviting stakeholders' comments.

Council conducted additional hearings / consultation sessions with Ward Committee's and Town Advisory Forums (TAF) during April 2013 in an attempt to deepen democracy and public participation for ownership of the budget.

VOORLEGGING VAN KONSEPBEGROTING

Die Konsepbegroting en begrotingsverwante dokumente is aan die Nasionale en Provinsiale Tesourie en ander sektordepartemente gestuur. Kennisgewings is in plaaslike koerante geplaas en die Konsepbegroting is op die munisipale webwerf geplaas met 'n uitnodiging vir kommentaar van belanghebbendes.

Die Raad het in April 2013 addisionele verhore / raadplegingsessies met Wykskomitees en Dorpsadviesforums gehou in 'n poging om demokrasie te verdiep en openbare deelname te bevorder in die lig van eienaarskap van die begroting.

DISCUSSION

Theewaterskloof Municipality has been delegated to the Provincial Treasury in terms of MFMA compliance and monitoring and thus no comments were received from National Treasury, but from Provincial Treasury – Western Cape.

BESPREKING

DOEL VAN VERSLAG

Om oorweging te skenk aan die herroeping van 'n besluit wat op 19 Februarie 2004 deur die Raad oor die betaling van bouersdeposito's en bouplanfooie vir gesubsideerde behuisingsprojekte geneem was.

AIM/PURPOSE OF REPORT

To give consideration to revoking a resolution taken by Council on 19 February 2004 regarding the payment of builder's deposits and building plan fees in respect of subsidised housing projects.

AGTERGROND

Die Raad van die dag het op 19 Februarie 2004 na aanleiding van 'n item wat voor die Raad gedien het as volg besluit:

- 1) Dat die Raad kennis neem van bovermelde inligting
- 2) Dat die Raad vrystelling verleen ten opsigte van die betaling van 'n bouersdeposito en bouplanfooie vir alle behuisingseenhede wat gedeeltelik of ten volle met behuisingssubsidie fondse opgerig/gebou word.

"n Afskrif van die volledige item R6/2004 is hierby aangeheg.

BACKGROUND

The Council at the time resolved as follows on 19 February 2004 regarding an item serving before Council:

- 1) That Council noted the above information.
- 2) That Council grants exemption in respect of the payment of a builder's deposit and building plan fees for all housing units partially or fully erected/built with the aid of housing subsidy funds.

A copy of the complete item R6/2004 is attached hereto.

BESPREKING

Ten tye van die neem van die betrokke besluit het die Raad self as implementerings-agent funksioneer en was die kostes van bouersdeposito's en bouplanfooie aanvanklik uit die administrasiekoste verhaal.

In die lig daarvan dat die Raad nie meer self die Implementeringsagent is nie, het dit nodig geword om oorweging daaraan te skenk om besluit R6/2004 van 19 Februarie 2004 te herroep.

DISCUSSION

At the time when the decision was taken, Council itself functioned as implementation agent and the costs of builder's deposits and building plan fees were initially recovered from administration costs.

In view of the fact that Council no longer acts as the Implementation agent, it has become necessary to consider revoking resolution R6/2004 of 19 February 2004.

WETLIKE IMPLIKASIE

Dit blyk dat daar geen beperkings in huidige wetgewing bestaan wat die herroeping van die betrokke besluit verhinder nie.

LEGAL IMPLICATION

It seems that no limitations exist in current legislation that would prohibit revoking the resolution in question.

FINANSIËLE IMPLIKASIE

Indien die besluit herroep word, sal dit verseker dat met die bou van toekomstige gesubsideerde behuisingseenhede die Raad 'n regmatige inkomste vir dienste gelewer sal ontvang welke betaling dan sal ooreenstem met alle ander gevalle wanneer bouwerk gedoen word.

FINANCIAL IMPLICATION

Should the resolution be revoked, Council would be ensured of receiving a rightful income for services rendered when future subsidised housing units are built, which payment shall correspond with all other cases when construction is undertaken.

PERSONEELIMPLIKASIE

Die administrasie verbonde aan die hef, verhaling en kontrole van bouplan deposito's en bouplanfooie gaan 'n geringe ekstra werkslading op die huidige personeel plaas, maar behoort dit, weens die beperkte omvang daarvan, nie 'n tekort aan personeel te veroorsaak nie.

PERSONNEL IMPLICATION

The administration involved in levying, recovering and control of building plan deposits and building plan fees will place a slight extra word load on the current staff, but, due to the limited extent thereof, should not result in a shortage of staff.

KOMMUNIKASIE-IMPLIKASIE

Die inhoud van hierdie item en die besluit van die Raad sal as 'n dringende aangeleentheid met die Implementeringsagente kommunikeer word sodat voorsiening reeds met die aanvang van gesubsideerde behuisingsprojekte vir die bouplandeposito's en bouplanfooie gemaak kan word.

COMMUNICATION IMPLICATION

The contents of this item and the resolution by Council shall be communicated to the implementation agents as an urgent matter so that provision for building plan deposits and building plan fees can be made upon the commencement of subsidised housing projects.

KOMMENTAAR VAN DIREKTORATE EN ANDER FUNKSIONARISSE:

Weens die dringendheid van hierdie aangeleentheid en ten einde die 2013/2014 Begroting te finaliseer, kon kommentare nie betyds ingewin word nie. Weens die feit dat die inhoud van hierdie item 'n administratiewe en wetlike implikasie het behoort dit nie enige verdere kommentaar as wat reeds in die toeligting vervat is te ontlok nie.

PURPOSE / AIM OF REPORT

This report serves to submit the 2013/2014 and indicative two outer years annual budget, tariffs, policies as well as the IDP for approval.
