## DECISION LETTER TO APPLICANT

---

Dear Mr/Mrs/Ms

### APPLICATION FOR CONSOLIDATION AND REZONING: ERF 631 & 632, GREYTON.

1. This application received 10 June 2020, refers.
2. The Authorised Employee, on 26 January 2021 **approved, in whole** your application for the following applications as per Consolidation Plan Nr.3 drawn by WRAP dated June 2020 in terms of Section 60 of the Theewaterskloof Municipality: By-law on Municipal Land Use Planning, 2015:
  - 2.1. **Rezoning** of Erf 631, Greyton from Authority Zone to Business Zone 1; and
  - 2.2. **Consolidation** of Erf 631 with Erf 632, Greyton to create a new consolidated erf
3. **Reasons** for the above decision are as follows:
  - 3.1. The proposed development is consistent with the provisions of the SDF.
  - 3.2. It is not foreseen that the proposal will infringe on the social welfare, development rights and privacy of the surrounding property owners.
  - 3.3. There are no restrictive title deed conditions prohibiting the approval of the application.
  - 3.4. Sufficient access and onsite parking is available.
  - 3.5. The proposal is compatible with the surrounding area.
  - 3.6. Sufficient engineering services are available.
4. **The abovementioned approval is subject to the following conditions in terms of Section 66 of the Theewaterskloof Municipality: By-law on Municipal Land Use Planning:**
  - 4.1. The proposal be generally in accordance with the Consolidation Plan Nr.3 drawn by WRAP dated June 2020;

- 4.2. The approval is valid for 5 years, after the expiry of the period contemplated in Section 79(2), in terms of Section 32(1) of the Theewaterskloof Municipality: By-law on Municipal Land Use Planning (2015);
  - 4.3. Complete building plans, for as-built structures and any new built structure, be submitted to the Department: Town Planning and Building Control for consideration and approval, before any construction activities commence;
  - 4.4. The approval of the application does not exempt the applicant/developer from compliance with any other legislation;
  - 4.5. Any service upgrades required be for the cost of the owner; and
  - 4.6. No structures to be erected within 2 meters of existing municipal infrastructure and the proposal should not obstruct the municipal connections.
5. You are hereby informed of your right to appeal to the Appeal Authority in terms of section 79(2) and 80 of the said legislation.
    - 5.1. The attached appeal form must be completed and should be directed to the Appeal Authority and received by the Theewaterskloof Municipality, 6 Plein Street, Caledon, 7230 telephone: 028 214 3300, within 21 days of notification of this decision together with proof of payment of the appeal fee.
    - 5.2. You are requested to simultaneously serve notice of the appeal on any person who commented on the application and any other persons as the Municipality may determine (see attached list). Proof of serving the notification must be submitted to the Municipality, within 14 days of serving the notification.
    - 5.3. The notice must be served in accordance with section 35 of the said legislation and in accordance with the additional requirements as may be determined by the Municipality. The notice must invite persons to comment on the appeal within 21 days from date of notification of the appeal.
  6. Kindly note that no appeal right exists in terms of Section 62 of the Local Government Municipal Systems Act, No 32 of 2000.
