

### APPLICATION FOR SUBDIVISION - REGISTRATION OF A PIPELINE SERVITUDE: FARM 331 ANNEX KROM RIVER, CALEDON DISTRICT

1. This application received, 25 August 2020, refers.
2. The Authorised Employee, on 17 February 2021 **approved, in whole** your application for **Subdivision for the registration of a pipeline servitude**, in terms of section 60 of the Theewaterskloof Municipality: By-law on Municipal Land Use Planning, 2015.
3. **Reasons** for the above decision are as follows:
  - 3.1. The proposal will not negatively impact on the engineering services.
  - 3.2. The proposal conforms to forward planning documents.
  - 3.3. No change in land use is proposed and as a result the character of the surrounding area will remain unchanged.
  - 3.4. The proposal will result in the effective utilisation of existing resources in the area.
  - 3.5. Basic infrastructure will be provided as a result of the application.
4. **The abovementioned approval is subject to the following conditions in terms of Section 66 of the Theewaterskloof Municipality: By-law on Municipal Land Use Planning:**
  - 4.1. The approval is valid for 5 years, after the expiry of the period contemplated in Section 79(2), in terms of Section 22 of the Theewaterskloof Municipality: By-law on Municipal Land Use Planning (2015);

- 4.2. The 4m wide water pipeline servitude must be registered at the Deeds Registrar and Surveyor-General's Office within the validity period of this approval, generally in accordance with Plan Ref.: CLDN Servitude, drawn by: EB, dated: 22 July 2020;
  - 4.3. The approval of this application does not exempt the applicant/developer from compliance with any other legislation; and
  - 4.4. Any service upgrades required be for the cost of the owner/applicant.
5. You are hereby informed of your right to appeal to the Appeal Authority in terms of section 79(2) and 80 of the said legislation.
- 5.1. The attached appeal form must be completed and should be directed to the Appeal Authority and received by the Theewaterskloof Municipality, 6 Plein Street, Caledon, 7230 telephone: 028 214 3300, within 21 days of notification of this decision together with proof of payment of the appeal fee.
  - 5.2. You are requested to simultaneously serve notice of the appeal on any person who commented on the application and any other persons as the Municipality may determine (see attached list). Proof of serving the notification must be submitted to the Municipality, within 14 days of serving the notification.
  - 5.3. The notice must be served in accordance with section 35 of the said legislation and in accordance with the additional requirements as may be determined by the Municipality. The notice must invite persons to comment on the appeal within 21 days from date of notification of the appeal.
6. Kindly note that no appeal right exists in terms of Section 62 of the Local Government Municipal Systems Act, No 32 of 2000.

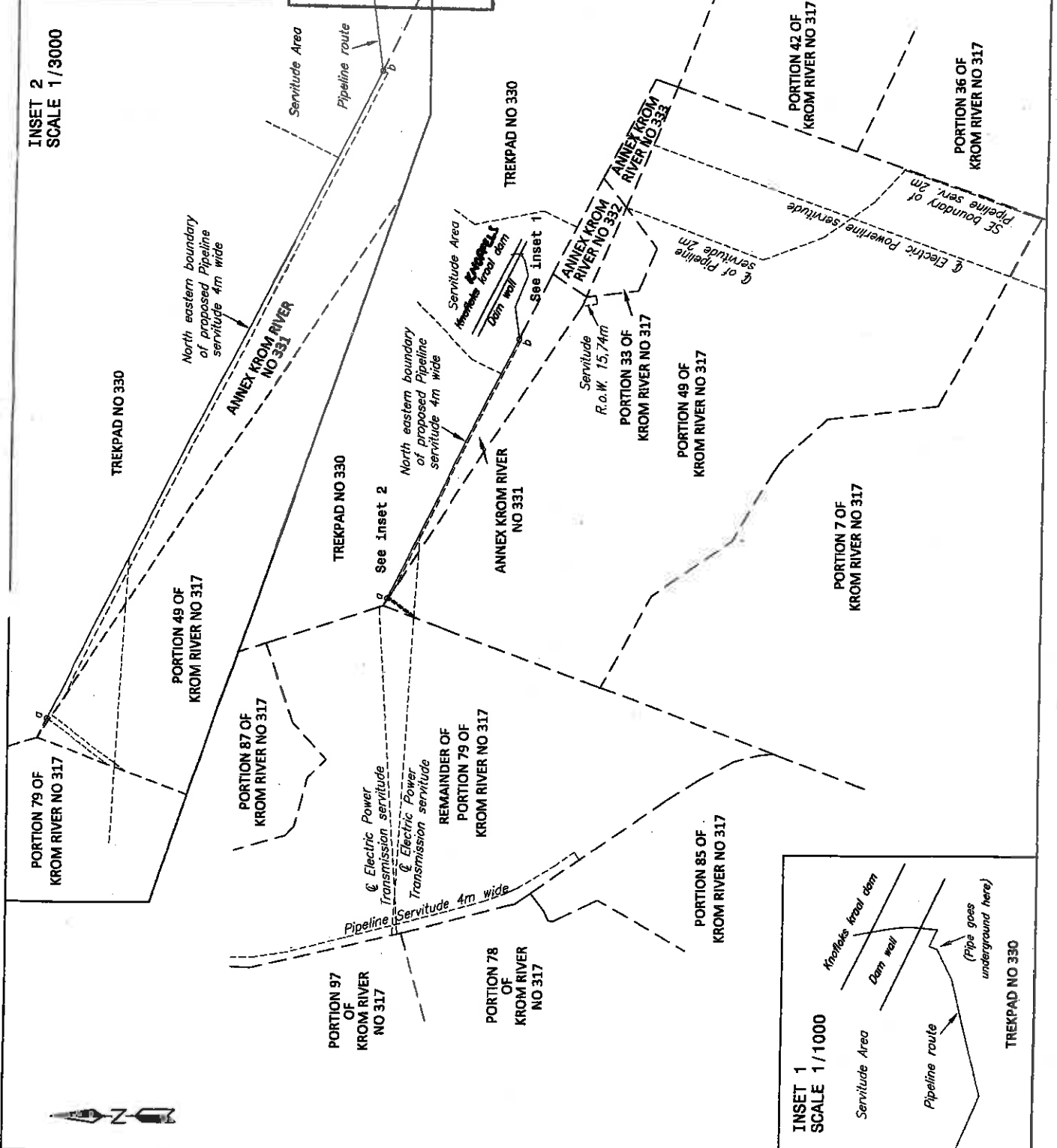

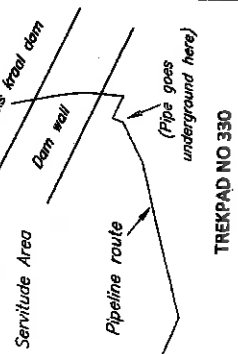
